CHANGES TO SUPPLEMENTARY REGULATIONS AS FOLLOWS;

ADD

The rally will now be called 'Rally Experience and Introductory Rally' and will be a Closed Club Special Stage Rally.

1. In the event program at the start of supplementary regulations Scrutineering and Documentation will only be available on Saturday 2 March between the hours of 0600 and 0800 at rally headquarters which is situated at Benarkin State School, unless Regional Scrutineering has been arranged.
2. Article 1 of Supplementary Regulations; the name of the rally has changed to 'Rally Experience and Introductory Rally'.
3. Article 4.1 of Supplementary Regulations;

5. Article 5.1 of Supplementary Regulations; Stewards of the Event; Kristy-Lee Kahler (Chair) and Paul Henningson.
6. Article 18.2 of Supplementary Regulations; Documentation will be available electronically when your entry is lodged or at Pre Event Documentation on **Saturday 2 March 2019 at Benarkin School** commencing at 0600hrs and finishing at 0800hrs.
7. Article 21.1 of Supplementary Regulations; All competitors who reside within 100kms radius of the GPO **must be scrutineered on the day Saturday 2 March 2019**, scrutineering is no longer available on any other days unless regionally scrutineered. **Scrutineering will commence at 0600hrs and all cars must be presented by 0800hrs.** Please note that scrutineering and documentation may go past this time.

8. Article 21.2 of Supplementary Regulations; Entrants no longer need permission from the Chief Scrutineer to scrutineer on the day.

9. Article 21.3 of Supplementary Regulations; Scrutineering on the day will commence at **0600hrs 2 March 2019** and last car will be booked into scrutineering at **0800hrs**. Documentation and scrutineering may go past this time.

10. New 25.4; **All drivers including additional drivers** must be a BSCC member or obtain a **Temporary membership** for BSCC on the day at a cost of \$20.

New 25.5; **Navigators must be a BSCC member** to obtain a **Temporary membership** for BSCC on the day at a cost of \$20.
