## **Privacy Policy**

Brisbane Sporting Car Club Limited (BSCC) values and respects the privacy of the people we deal with. BSCC is committed to protecting your privacy and complying with the Privacy Act 1988 (Cth) (**Privacy Act**) and other applicable privacy laws and regulations.

This Privacy Policy (**Policy**) describes how we collect, hold, use and disclose your personal information, and how we maintain the quality and security of your personal information.

This Policy applies to our website, www.bscc.asn.au, and other services provided by BSCC.

## What is personal information?

"Personal information" means any information or opinion, whether true or not, and whether recorded in a material form or not, about an identified individual or an individual who is reasonably identifiable. In general terms, this includes information or an opinion that personally identifies you either directly (e.g. your name) or indirectly.

## What personal information do we collect?

The personal information we collect about you depends on the nature of your dealings with us or what you choose to share with us.

The personal information we collect about you may include:

- Name;
- Mailing and/or street address(es);
- Date of Birth;
- Email address(es);
- Phone number(s);
- Medical condition(s);
- Motorsport Australia and civil drivers' license details; and
- Next of Kin name and contact details.

Under certain circumstances, BSCC may need to collect sensitive information about you. This might include your health information. If we collect your sensitive information, we will do so only with your consent, if it is necessary to prevent a serious and imminent threat to life or health, or as otherwise required or authorised by law, and we take appropriate measures to protect the security of this information.

You do not have to provide us with your personal information. However, if you choose not to provide us with your personal information, we may not be able to provide you with our services or otherwise interact with you.

## How do we collect your personal information?

We collect your personal information directly from you when you:

- interact with us over the phone;
- interact with us in person;
- interact with us online;
- participate in surveys or questionnaires;
- attend a BSCC promoted event;
- subscribe to our mailing list;
- apply for a position with us as an employee, contractor or volunteer; or
- participate in a Motorsport Australia sanctioned event run by BSCC.

### Collecting personal information from third parties

We may also collect your personal information from third parties or through publicly available sources, for example from the Motorsport Australia competitor registration system. We collect your personal information from these third parties to properly effect the running of Motorsport Australia sanctioned events run by BSCC.

## How do we use your personal information?

We use personal information for many purposes in connection with our functions and activities, including the following purposes:

- the operation of Motorsport Australia sanctioned events promoted by BSCC;
- the operation of other events run by BSCC;
- internal administrative purposes; and
- event marketing purposes.

## Disclosure of personal information to third parties

We may disclose your personal information to third parties in accordance with this Policy in circumstances where you would reasonably expect us to disclose your information. For example, we may disclose your personal information to:

- Motorsport Australia in order to conduct events in accordance with Motorsport Australia sanctioning requirements;
- BSCC's information technology support suppliers, in the undertaking of their essential duties with BSCC information assets; and
- BSCC event specific volunteer officials, where needed for those volunteer officials to conduct events for and on behalf of BSCC.

### Transfer of personal information overseas

BSCC does not presently utilise third parties or providers who have, or use, assets or infrastructure in overseas locations. BSCC has taken steps to ensure that your information remains in Australia while BSCC remains responsible for that information.

Where we disclose your personal information to third parties overseas, we will take reasonable steps to ensure that data security and appropriate privacy practices are maintained. We will only disclose to overseas third parties if:

- you have given us your consent to disclose personal information to that third party; or
- we reasonably believe that:
  - o the overseas recipient is subject to a law or binding scheme that is, overall, substantially similar to the APPs; and
  - o the law or binding scheme can be enforced; or
- the disclosure is required or authorised by an Australian law or court / tribunal order.

### How do we protect your personal information?

BSCC will take reasonable steps to ensure that the personal information that we hold about you is kept confidential and secure, including by:

- having robust physical security of our premises and databases / records;
- taking measures to restrict access to only personnel and third parties who need that personal information to effectively provide services to you;
- having technological measures in place (for example, anti-virus software, fire walls); and
- minimising the amount of information BSCC stores to the minimum required to effect BSCC's goals.

### Online activity

#### Cookies

The BSCC website uses cookies. A cookie is a small file of letters and numbers the website puts on your device if you allow it. These cookies recognise when your device has visited our website(s) before, so we can distinguish you from other users of the website. This improves your experience and the BSCC website(s).

We do not use cookies to identify you, just to improve your experience on our website(s). If you do not wish to use the cookies, you can amend the settings on your internet browser so it will not automatically download cookies. However, if you remove or block cookies on your computer, please be aware that your browsing experience and our website's functionality may be affected. This may be particularly relevant in the event that you register for an event run by BSCC.

#### Website analytics

Our website uses online analytics to help us better understand visitor traffic, so we can improve our services. Although this data is mostly anonymous, it is possible that under certain circumstances, we may be able to connect it to you.

#### Direct marketing

We may send you direct marketing communications and information about our services, opportunities, or events that we consider may be of interest to you if you have requested or consented to receive such communications. These communications may be sent in various forms, including mail, SMS, fax and email, in accordance with applicable marketing laws, such as the *Australian Spam Act 2003* (Cth). You consent to us sending you those direct marketing communications by any of those methods. If you indicate a preference for a method of communication, we will endeavour to use that method whenever practical to do so.

You may opt-out of receiving marketing communications from us at any time by contacting us using the details set out in the "How to contact us" section below.

In addition, we may also use your personal information or disclose your personal information to third parties for the purposes of advertising, including online behavioural advertising, website personalisation, and to provide targeted or retargeted advertising content to you (including through third party websites).]

## Retention of personal information

We will not keep your personal information for longer than we need to. In most cases, this means that we will only retain your personal information for the duration of your relationship with us unless we are required to retain your personal information to comply with applicable laws, for example record-keeping obligations.

## How to access and correct your personal information

BSCC will endeavour to keep your personal information accurate, complete and up to date.

If you wish to make a request to access and / or correct the personal information we hold about you, you should make a request by contacting us and we will usually respond within 20 business days. We will deal with such a request by following the procedure outlined below:

We make no representations or warranties in relation to the privacy practices of any third party provider or website and we are not responsible for the privacy policies or the content of any third party provider or website. Third party providers / websites are responsible for informing you about their own privacy practices and we encourage you to read their privacy policies.
